## **ENTRY VISA FOR “FAMILY REASONS” FOR FOREIGN FAMILY MEMBERS OF FOREIGN NATIONALS LEGALLY RESIDING IN ITALY (V.N.)**

The family reunification visa allows entry into Italy to family members included in the Nulla Osta (certificate of no impediment) issued by the Sportello Unico Immigrazione (Immigration Office), who fall within the following categories listed in Art. 29 of Legislative Decree n.286/1998:

1. Spouse (or Civil partners) not legally separated and not under 18 years of age;
2. Children under 18 years of age, including children of the spouse, including those of the spouse or born out of wedlock, provided they are unmarried and subject to the consent of the other parent, if living. Shall be considered minors the children who have not reached the age of 18 at the time the application for the Nulla Osta is submitted to the SUI (Unified Immigration Desk);
3. Dependent children who are 18 years or over, if they are unable to support to their indispensable necessities of life because of their health conditions entailing total disability;
4. Dependent parents, if they have no other descendants in their country of origin or provenance who can support them;
5. Parents over the age of 65, when the other children present in the country of origin or provenance cannot provide for their support for documented, serious health reasons.

### Please note:

Dependent parents must prove there are no descendants in their country of origin, their health condition and their dependant status with any evidence, such as: wire transfers, receipts of money transfers, provision of accommodation, rental payments, documents certifying that the applicant does not have income deriving from annuities or pensions, demonstration that the applicant does not have any source of income or rather that their sources of income is insufficient for their own maintenance in the local economic and social context.

### **Applicants should always appear in person. Applicants must provide:**

1. Duly completed application form (in English or in Italian);
2. Valid passport or travel document (original plus one photocopy), valid for at least 3 months beyond the return date from Italy and with at least two blank pages;
3. Proof of residency in Georgia and possession of a valid Georgian residence permit (original plus a photocopy), which must still be valid for at least three months upon return from the trip;
4. One photograph, compliant with ICAO standards and taken within the last six months;

5. Nulla Osta issued no more than 6 months earlier by the competent “Sportello Unico (SUI)” in Italy;
6. Proof of relationship: marriage/civil partnership/birth certificate (original plus one photocopy). Please note:
  1. Marriage/civil partnership certificates older than 6 months will NOT be accepted;
  2. Certificates issued by a Georgian authority MUST bear the “Apostille”;
  3. Certificates issued by a foreign authority other than Georgian MUST be translated in English or Italian and legalized by the Italian Consular Office of the issuing Country OR by the Consular Authority in Georgia of the issuing Country;
  4. Certificates issued by one of the European Union countries will be accepted without legalization only if multilingual (otherwise, please refer to point 3);
7. Photocopy of residence card or long-term resident’s EU residence permit of the family member in Italy;
8. In case of minors, written consent from the other parent granting permission to travel for family reunification. Please note:
  1. the parental consent must be notarized by a Georgian notary, translated and apostilled;
  2. if the parent lives abroad, the consent must be notarized by the Italian Consulate of their country of residence (for more information, please visit the following website <https://www.esteri.it/mae/en/servizi/stranieri/traduzionelegalizzazione-dei-documenti.html>). This also applies when parents living abroad nominate a guardian;
  3. a photocopy of both parent’s passports must be provided.
9. One way travel ticket reservation. Please note: ticket must show reservation number, airline company name, passenger’s name, dates of travel and itinerary;
